MAATAURANGA MAAORI GRANT

MAATAURANGA TOI GRANT

1. All registered tribal members are entitled to apply for a Maatauranga Maaori or Maatauranga Toi grant, as individuals or on behalf of their Marae/group/organisation. The proposed initiative or activity must benefit members of one or more of the 67 Waikato Raupatu registered Marae.
2. Applications will be considered for initiatives or activities that promote, preserve, advance and maintain Maatauranga Maaori, and may include:
 - a. participation/representation at kaupapa Maaori events;
 - b. participation/representation at other events which contribute to promotion, preservation, advancement and maintenance of Maatauranga Maaori.* Priority will be given to initiatives and activities with a Waikato-Tainui focus.
3. Applications will be considered for initiatives or activities that promote, preserve, advance and maintain Maatauranga Toi, and may include:
 - a. promotion and/or exhibition of an artist's work;
 - b. attending performing/creative arts events;
 - c. tuition for performing/creative art courses (if not NZQA recognised).* Priority will be given to initiatives and activities with a Waikato-Tainui focus.
4. Only one grant will be paid per individual or group/organisation within a financial year. A financial year is from 1 April to 31 March.
5. Applications are considered monthly and close on the second Friday of the month.
6. Where an application is made on behalf of a group/organisation, at least 50% of the group/organisation must be registered tribal members. To verify tribal registration, the full names and birth dates of the persons benefiting from the grant, must be supplied in support of the application. Note: This criteria does not apply to applications made on behalf of Waikato Raupatu Marae.
7. Full details of the event, expected outcomes, date(s), venue, and a full budget must be supplied in support of the application.
8. Sole discretion to accept or decline an application that does not meet the criteria, rests with the Waikato Raupatu Lands Trust. Decisions are final and no correspondence will be entered into.
9. Pursuant to the Privacy Act 1993, signing and submitting this application authorises the Waikato Raupatu Lands Trust to record, hold and publish names of each grant recipient. Grant details may also be used for publicity and promotion purposes, and successful applicants may be contacted for evaluation and review.
10. Where appropriate, successful applicants must acknowledge the Waikato Raupatu Lands Trust as a sponsor.
11. On request, successful applicants must complete an accountability statement to verify that funding was expended for the purpose it was provided. Copies of invoices/receipts must be included with an accountability statement.
