BACKGROUND

Tainui Sports Limited was formed in 2007 by Waikato Raupatu Trustee Company to promote and foster a healthy and active tribe by funding registered tribal members to participate fully in sporting and recreational activities.

WHO CAN APPLY FOR A SPORTS GRANT?

- Individual athletes or administrators who are enrolled on the Waikato-Tainui Tribal Register (an administrator refers to a coach, manager, referee or umpire only)
- Teams, clubs or regional associations with a minimum of 50% membership, enrolled on the Waikato-Tainui Tribal Register (a list of your members may be requested by Tainui Sports staff)
- Waikato-Tainui Raupatu Marae or clusters of Waikato-Tainui Raupatu Marae, for sporting activities.

FUNDING MAY BE AVAILABLE FOR

- Travel, fees & accommodation to participate in local, regional, national and international competitions or tournaments.
- Uniforms or specialised sporting equipment required for full participation in activities
- Travel, fees and other costs associated with athlete training
- Professional Development and costs for sports administrators
- Other costs that the Directors may consider appropriate

FUNDING IS NOT AVAILABLE FOR

- Personal equipment or training items for individuals
- Costs associated with after match functions or social gatherings

GENERAL PROVISIONS FOR APPLICATIONS

1. Close on the second Friday in January, March, May, July, September and November
2. No late applications will be accepted
3. Applications need to be for future spending, not for events held prior to the closing date
4. Applicants may only receive one grant per financial year. A financial year is from 1 April to 31 March.
5. Individual applications for Tainui Sports Limited sponsored team events or activities, will be considered at the discretion of the Directors.
6. A budget for the initiative or activity, must be provided with the application.
7. Applications for travel, accommodation, uniforms and equipment must be supported by 2 quotes, unless costs have been set by a Regional or National body
8. Quotes must be on suppliers letterhead and less than 3 months old
9. For applications from clubs, marae, regional & national associations, a copy of the resolution to apply for funding must be supplied
10. Tainui Sports decision is final and no correspondence will be entered into

CONDITIONS OF GRANT

- All grants are to be used for the purposes applied for
- Copies of invoices or receipts must be submitted to Tainui Sports within 6 months of the grant being paid, or the event being held
- Recipients to provide a brief report of their achievements at competitions or tournaments
- Any grant monies not spent on the approved purpose must be returned to Tainui Sports. Failure to comply with this will impact on future applications
- Recipients may be asked to participate in Waikato-Tainui tribal events, school or marae promotional programmes as role models
- Tainui Sports may request your consent to use articles or photos for promotional purposes

PLEASE PROVIDE DETAILS AS REGISTERED ON THE WAIKATO-TAINUI REGISTER.

- For applications submitted by individuals, benroll number to be confirmed with the Tribal Registry Office.

- Applications received from clubs, marae, regional or national societies should be submitted by one of its officers (Chairperson, Secretary or Treasurer)
